WHEREAS:

CLAUSE 1

CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual and skill development resources and capabilities.
- 1.3 The parties shall co-operate with each other and shall act as promptly as possible through a responsibly practical and relevant agreement.

CLAUSE 2



SCOPE OF THE MoU

- 2.1 Seminars/ Conferences/ Workshops/Lecture Programmes: Both Parties may jointly organize National/International/State level seminars/conferences/workshops/lecture programmes to develop requisite skill amongst current students and alumni.
- 2.2 Various Online/Offline skill development Courses may be organized for the students by both the Parties in collaboration.
- 2.3 Trainings/Workshops and Placement: The two Parties may conduct useful technology and skill-based training programmes for students of school and college levels. The training programme will be conducted mainly on Information Technologies Enable Service (ITES - BPO Training), Customer Relationship and Sales (CRS), after completion of the said training, the placement assistance will be offered too.

CLAUSE 3

VALIDITY

- 3.1 This Agreement will be valid for a period of Three (3) year and will require the approval of the Executive Committee for further extension.





RELATIONSHIP BETWEEN THE PARTIES


