This Memorandum of Understanding (MoU) is made on 28th Day of November, 2022 between Bangabasi Morning College and Sonarpur Mahavidyalaya for mutual cooperation witnesseth in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two organisations:

I. Legal Frameworks of Both the Organizations

Bangabasi Morning College, established in 1965, is an undergraduate college, affiliated with the University of Calcutta and recognized by the UGC U/S 2f and 12B, has its campus at 19, Rajkumar Chakraborty Sarani, Kolkata, Pin- 700009, West Bengal, India. The college admits students irrespective of caste, creed and religion and teaches through the medium of English and Bengali according to the syllabus laid by the University of Calcutta. It is represented by its Principal, Dr. Amitava Dutta, hereinafter referred to as the **FIRST PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns).

Sonarpur Mahavidyalaya, established in 1985, is an undergraduate college, affiliated with the University of Calcutta and recognized by the UGC U/S 2f and 12B, has its campus at Sahid Biswanath Sarani, P.O.- Rajpur, 24 Parganas(S), Pin- 700 149, West Bengal, India. The college admits students irrespective of caste, creed and religion and teaches through the medium of English and Bengali according to the syllabus laid by the University of Calcutta. It is represented by its Principal, Dr. Ujjal Ray, hereinafter referred to as the **SECOND PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will hereafter be referred to as Parties.

II. Purpose of the Agreement

Both the Parties are pleased to enter into an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through the following, but not limited to:

1. Joint teaching and research projects.
2. Collaboration in the area of academic publications, research activities, field trips, etc.
3. Visits, training, and exchange of faculty, staff, and students.
4. Joint educational/vocational courses.
5. Joint consultancy, PhD supervision, scientific publications.
6. Co-hosting and participation in conferences, seminars, symposiums, and workshops.
7. Social and cultural programs.
8. Any other academic activity that is mutually agreed upon and is beneficial to both.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.
